Access to closed discussion groups.

Optional English coaching (if subscribed)

All services are provided online and conducted in English.

The club has no legal relationship with the authors or publishers of the selected books. All supplementary materials are independently created and developed by the organizers.

3. Membership and Participation

Membership is open to individuals aged 18 and older. The discussions are open to all, though the focus is often on topics relevant to women's perspectives.

Members agree to follow the [group rules](#).

Membership may be suspended or terminated in case of rule violations as outlined in the group rules.

4. Subscription and Payment

Payments are made in EUR by bank transfer.

Invoices are issued by Zsuzsanna Vatainé Lengyel and Zsuzsa Mártonffy directly.

Memberships are valid for a defined period and do not automatically renew. Renewal requires explicit confirmation by the member.

Members who do not renew will lose access at the end of their current paid period.

5. Cancellation and Refunds
